

TO MERITS OF ARGENTINE COMPLAINT. I ADDED (AS AUTHORIZED DEPCIR 1589) THAT IF ISSUE DID COME TO SC WE WOULD SUPPORT ARGENTINE RES WITH RELATIVELY MINOR CHANGES IN RES. (I HAD NOT INTENDED TO BE THIS EXPLICIT ON OUR SUPPORT FOR ARGENTINA RES AS I BELLEVED. IT MIGHT UNDERCUTREFFORTS TO PERSUADE ARGENTINES TO FOREGO SC MEETING, BUT INASMUCH AS AMADEO SEEMED TO SUSPECTIVE WAS WORKING BEHIND HIS BACK TO PREVENT SC SESSIONED THAT ALL THIS MADE SENSE AND IT SEEMED MOST LIKELY MESSAGE HAD BECOME GARBLED BETWEEN ITS TRANSMISSION IN PARIS AND ITS RECEIPT BY AMADEO HERE.
